NC House Bill 76 ("Access to Healthcare Options")

Medicaid expansion:

- Establishes a program called NC Health Works to expand Medicaid to cover people ages 18-64 earning up to 133% of the federal poverty level.
 - This will provide new coverage for an estimated 600k North Carolinians.
- Provide increased Medicaid reimbursements to hospitals through the Healthcare Access and Stabilization Program (HASP) upon federal approval of a request developed and submitted by the Department of Health and Human Services (DHHS).
 - Anticipated that North Carolina's hospitals will see more than \$1.8 billion in additional federal dollars.
- Federal government funds 90% of the cost, NC 10%. (For traditional Medicaid, states pay 25-50% of the cost.)
 - The state would pay its 10% share of the program through hospital assessments, savings offset by the Medicaid expansion program, and gross premium taxes paid by the Medicaid managed care companies.

Changes to the CON law:

- Immediate:
 - Exempt from CON review all new behavioral health and chemical dependency beds
 - Change the review threshold for same-site renovations, expansion, or replacement of facilities from \$2 million to \$4 million.
 - Change the equipment replacement review threshold from \$2 million to \$3 million.
- In 2 years and only in counties with a population >125k:
 - Exempt from review ambulatory surgical facilities. These will be required to commit 4% of their total earned revenue to charity care.
- In 3 years and only in counties with a population >125k:
 - o Exempt MRI scanners from review.

Where does the legislation stand?

- Passed by NC House and Senate (3/21/23) and signed by governor 3/27/23.
- However, activation of the bill is triggered by passage and signing of 2024 budget which is expected in June, but subject to the usual politics.
